Terms and conditions for a Publishing prize draw or competition

1. Our prize draws and competitions are organised by Blast Log Limited (known simply as 'Blast Log') of 30 Grovehall Parade, Beeston, Leeds LS11 7AE.

How to enter

2. Entries received after the stated closing date will not be accepted.
3. Our prize draws and competitions are free to enter and no purchase is necessary
4. Blast Log will not accept responsibility for entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
5. By submitting an entry, you are agreeing to be bound by these Terms and Conditions. If you have any questions, please contact info@blastlog.co.uk
6. Blast Log reserves the right to refuse entry, or refuse to award the prize to anyone in breach of these terms and conditions.

Eligibility

7. Unless otherwise stated, our prize draws and competitions are open to all except employees of Blast Log, their families, agents or any third party directly associated with administration of the prize draw.
8. Entrants under 18 must get consent from their parent(s) or legal guardian(s) before entering. The parent(s) or legal guardian(s) of entrants under 18 agree to these Terms and Conditions on behalf of the entrant.
9. Only one entry per person is permitted.
10. In entering, you confirm that you are eligible to do so and eligible to claim any prize you may win. Blast Log may require you to provide proof that you are eligible to enter the prize draw or competition.

11. Blast Log reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize draw or competition.

The Competition

1. The winner will be notified by email or telephone (using details provided at entry) within 7 days of being chosen and must provide a postal address to claim their prize. If a winner does not respond to Blast Log within 14 days of being notified, then the winner's prize will be forfeited and Blast Log will be entitled to select another winner in accordance with the process described above.
2. The prize will be sent to the winner within 14 days of responding to Blast Log.
3. In the event of a drawn competition a winner will be selected at random from the drawing participants.
4. The prize is non-exchangeable, non-transferable and no cash alternative is offered. Blast Log reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond Blast Log's control makes it necessary to do so.
5. The decision of Blast Log regarding any aspect of the prize draw or competition is final and binding and no correspondence will be entered into about it.

Governing law
